1. Maintain your credentials; earn CEUs.

Attend the **Florida School Plan Management Association annual conference** and look for our School IPM all-day training on Sept 4 titled "Preventing Itches, Sneezing and Wheezing: Pest Management Counts". Asthma is on the rise and can be one of the leading reasons for student absenteeism, impacting learning, testing and productivity. Learn how pests in the school environment contribute to allergies and asthma and how to control these pests. Join our "Fix the Building Envelope" campaign.

2. Doing the job of 2 or 3 people and need help?

The Florida School IPM Industry Task Force has developed Best Management Practices tailored for Florida pest conditions. They are intended to help you design an integrated pest management program for your schools. The **draft is available for comment** until Sept 15, 2012, 5:00 PM.

EPA Region 8 has published an excellent guide to "**Sensible Steps to Healthier School Environments**" which includes organizational checklists to help keep track of your different responsibilities.

## Know the Facts: Asthma

- Asthma is a common chronic disease among children in the US
- In 2006, 9.9 million children under 18 years of age were reported to have ever been diagnosed with asthma; 6.8 million children had an asthmatic episode in the last 12 months
- The hospitalization rate for asthma remained at 27 per 10,000 children from 2002-2004
- Asthma is the third ranking cause of non-injury related hospitalization among children less than 15 years of age

### Disparities of Asthma

- Asthma disproportionately affects children from lower-income families and children from various racial and ethnic groups
- African-American children have a 500% higher mortality rate from asthma as compared with Caucasian children
- In 2005, 13% of African-American children were reported to have asthma as compared with 9% of Hispanic children and 8% of non-Hispanic white children

### Economic Impact of Asthma

- In 2002, children 5-17 years old missed 14.7 million school days due to asthma
